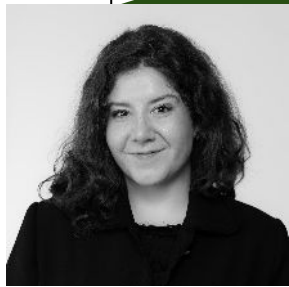

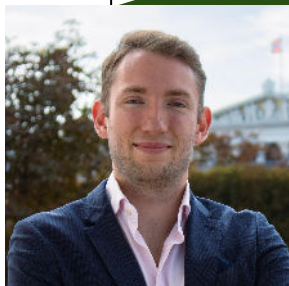


Ms. LUÍSA QUINTÃO

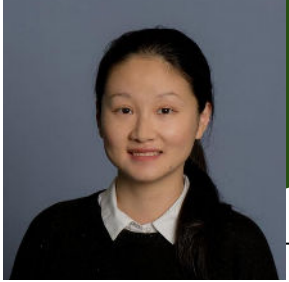

Harvard Law School

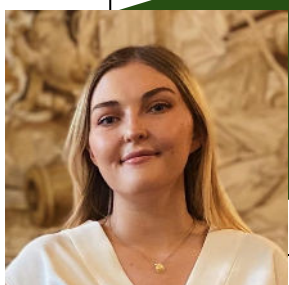

Beyond his involvement in the Vis Moot, David is also a Teaching Assistant (on leave) and a PhD Researcher at the University of Vienna's Department of Civil Procedure, where he teaches European and International Civil Procedure. His PhD thesis centers on the *res judicata* effects of competition law decisions before state courts and arbitral tribunals.
